Dear Principal Williams,

I am writing regarding Kaleb's attendance record.

Since December 3, 2025, Kaleb's absences have been marked as *unexcused*. We are formally requesting that **all absences beginning December 3, 2025, and any ongoing absences that occur while the district's unresolved safety and implementation issues remain outstanding, be corrected and marked as excused absences.**

As documented in our December 2025 CDE Compliance Complaint, Kaleb's inability to attend school is the direct result of district-created safety concerns and the district's failure to implement essential IEP-required supports. Because these conditions make attendance unsafe and prevent Kaleb from accessing his placement, these absences cannot appropriately be recorded as "unexcused."

Accordingly, we request:

- 1. That all absences beginning December 3, 2025, and any continuing absences tied to the unresolved issues, be corrected and marked as excused; and**
- 2. Written confirmation once these corrections are completed.**

We will also share this update with the assigned CDE investigator as part of our ongoing complaint.

I am following up on my email dated **December 11, 2025**, which was copied to district special education leadership, regarding our request that Kaleb's absences **beginning December 3, 2025, and any ongoing absences related to unresolved district safety and implementation issues**, be corrected and marked as **excused**.

As of today, we have received **no response** from the school or the district, and Kaleb continues to be marked with *unexcused absences* despite the unresolved conditions that prevent his safe attendance.

Given that district leadership has been aware of this issue since December 11, we are requesting a written response by Tuesday, December 23, 2025 confirming either:

1. That the attendance records have been corrected; or
2. The district's position regarding this request.

If we do not receive a response, we will treat the lack of action as a refusal and will provide this information to the California Department of Education as part of our ongoing compliance complaint.
